What data do we collect?

How do we collect your data?

- Use or view our website via your browser's cookies.

How will we use your data?

How do we store your data?

Loisico Tours securely stores your data at Houston Texas USA and on google platforms.

Loisico Tours will keep your information for an indefinite period of time on the Houston servers and for a period of 5 years on the google platforms. Once this time period has expired, we will automatically delete your data on the google platforms.

What are your data protection rights?

Loisico Tours would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Loisico Tours for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Loisico Tours correct any information you believe is inaccurate. You also have the right to request Loisico Tours to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Loisico Tours erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Loisico Tours restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Loisico Tours's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Loisico Tours transfer the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

How do we use cookies?

Loisico Tours uses cookies in a range of ways to improve your experience on our website, including:

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Loisico Tours uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – Loisico Tours uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Loisico Tours sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
